**Footnotes**

LION'S DEN tracked the pace early from the inside, angled off the rail into the turn then drew clear in the stretch and held late. PRAYER ANSWERED chased the pace early, fanned into the seven path in the turn then rallied in the stretch but did not have enough late. YABA DEVA DUE was unhurried early, angled into the four path in the turn with a mild gain in the stretch run. JEMARU was back early, angled into the five path in the turn with a belated gain in the stretch drive. PONCIRUS was on the inside into the turn and moved up in the stretch. U TEACHEM CART was well placed early, angled into the three path in the turn and weakened late. RED FOR THE CURE tracked the pace early, angled into the four path in the turn and faded late. STROLL WITH ME dueled early, angled into the three path in the turn and gave way in the stretch. SULTRY DEMEANOR was through after a half.
