BRICKYARD chased the dueling leaders early, angled into the four path in the far turn then took over command and drew away late under a brisk drive. POWERPOINTER stalked the pace early, angled off the rail into the far turn and weakened late in the stretch run. TYCOON dueled early, while on the inside into the far turn and faltered late in the stretch drive. OBLIGINGLY tracked the pace early, angled into the three path in the far turn then made a bid but faded late in the stretch. ELECTRIC ALPHABET dueled early, angled off the rail into the far turn and was empty in the stretch. MOUNTAIN JUSTICE trailed the field throughout.
