DUNRAVEN PASS broke alertly but was soon taken back to rate behind dueling pacesetters, shifted out for a three wide move at the three sixteenths pole, tackled the leaders at the top of the lane, was given cue and drew off inside the final eighth. LAYIN LOW was hard used early on, dueled while on the rail, outfinished dueling rival for place but was no match for the winner. CHIA SPICE dueled while two wide throughout, weakened late. NORTHERN CHAMP raced mid-pack, floated out to the four path on the turn and in the lane, no rally. FLEET DECISION trailed early, was floated six wide on the turn by a rival, no threat. SEATTLE EX was well off the pace early, got out on the turn to race in the five path while floating a rival wide, no factor.
