LADY CHARLIE pressed the pace along the inside, forged command entering the stretch, edged clear and held a diminishing advantage. JOYOUS VICTORY settled saving ground, advanced between horses through the turn, worked her way to the outside entering the stretch, finished well and was getting to the winner too late. KATY LIED settled in hand, made a sweeping move four wide through the turn, loomed large entering the stretch but flattened during the drive and settled for the minor award. AULIVIA JEHANNE was unhurried into stride, made a late rally five wide and improved position. SWEDEN was allowed to settle, slipped through along the rail to make a late rally. LOVELEIGH contested the pace between horses to the final furlong and faded. MY DELLA contended between horses four wide to the stretch and gave way. SLUMPBUSTER came six wide but lacked a response when asked. I THINK I CON vied for the lead four wide, but came up empty from between horses after six furlongs and dropped out. NATIVE KITTEN was hung wide through the turn and was never a factor. FLORIDA EXCESS pulled to contention between horses, but faltered after a half and faded fast.
