POPS LADY V. settled in hand, launched her bid four wide, angled in entering the stretch, split rivals and gamely edged clear. NOLIN LAKE was allowed to settle, angled out and made a bold bid five wide, but was unable to match strides with the winner and settled for the place. WITTY AND WISE angled in to save ground, got through and was up in time to earn the show. TRUST SLEW attended the pace three wide, came four wide and assumed command with a quarter to run, but weakened from between horses in the drive and gave way. TABLE FOR FIVE was close up while widest off all, but faltered in the final furlong and faded. BETTY R was allowed to settle, angled in to save ground but lacked a response when called upon. DREW'SGETLEAGLE was forwardly placed along the inside to the stretch and retreated. LION QUEEN contended along the inside for a half and dropped out. QUEEN GRACIE set the pressured pace off of the inside, shook clear off of the hill, but was collared leaving the turn and stopped. GRAND SEATTLE was always outrun. LUCYS SULTRY MOVES was caught in tight from between horses, clipped heels and unseated her jockey. The Stewards conducted an inquiry into the incident involving LUCYS SULTRY MOVES, but following the review made no change to the order of finish.
