Footnotes

WAR HOOT angled in early when forwardly placed, tracked the leaders off the inside, came three wide into the stretch, bumped BARYSHNIKOV once in the stretch then closed well to be up in time. CHEROKEE SPEED set the pace along the inside, repulsed a bid by BARYSHNIKOV on the second turn, drew clear into the stretch but was outfinished. VANONThERUN within striking distance early four wide, stayed in that path on the second turn, dropped back a

bit in midstretch then improved his position late between rivals. OLYMPIST outrun along the inside, saved ground on the second turn but lacked a late bid. COSMIC KING reserved off the inside, angled out and made a four wide middle move but could not sustain the bid. BARYSHNIKOV pressed the pace off the inside, was bumped by the winner in upper stretch and tired. CAUSE OF FREEDOM within striking distance along the inside, steadied entering the second turn then had no late bid. KENNESSEY within reach early, raced off the rail on the second turn and tired. DUBAI ECHO broke in the air, was outrun and never threatened. KUSCH was no factor. STAGE DELI was no threat. CALIFORNIA STRIKE close up three wide, stopped.
