GREAT THOUGHT, never far back and four wide, inched to challenge leaving the quarter-mile ground, was brushed by CAPE COD BAY lightly, drifted in under right-handed urging forcing CAPD COD BAY to steady about the sixteenth pole, took over and held sway. FAVORITE FANTASY moved to the fore inside early, accomplished slow fractions, lost the edge to the winner about the sixteenth pole and held on stubbornly the remainder as second best. TATES QUEEN settled early, edged near the inside, fanned seven wide entering the stretch and managed a mild gain. SKY COPPER, steadied between foes entering the first turn, raced within easy striking distance, maneuvered five wide for the drive but couldn't offer the needed late response. CAPE COD BAY went up to press FAVORITE FANTASY through slow fractions early, continued forwardly to the stretch while between foes, came out and brushed with GREAT THOUGHT for a stride nearing the three-sixteenths pole, then was forced to steady and was squeezed back at the sixteenth pole when GREAT THOUGHT drifted in tightening it up on him. SOLEMN VOW, well placed and racing near the inside throughout, loomed a solid threat for the last eighth and flattened out. ALBANY HOUSE wasn't a serious factor. EMBELLISHMENT, five wide, failed to menace. C. R. PRINCESS, between foes and forwardly placed, weakened nearing the lane. FOLLOWING A STEWARDS' INQUIRY AND FOUL CLAIM BY THE RIDER OF CAPE COD BAY FOR ALLEGED INTERFERENCE IN THE STRETCH, GREAT THOUGHT WAS DISQUALIFIED FROM FIRST AND PLACED FIFTH.
