NORDIC BULL was unhurried early, swung into the six path in the turn then rallied in the stretch and drove past the leader and inched clear in the final stages. MR. CHOW chased the pace early angled into the five path in the turn then floated in a bit in the stretch and yielded in the final stages. MONEY FAN was bumped at the start then trailed the field early, angled into the four path in the turn then made a bid in the stretch but flattened out late in the drive. FAVORITE COACH set the pace early, while on the inside into the turn and faltered late in the stretch run. WAR READY was knocked off stride at the start and was well placed early, angled off the rail into the turn and weakened late in the stretch drive. COUNTY CORRECTIONS bumped a rival at the start then raced up close early, shied from the rail along the backstretch then checked hard into the turn and faded along the stretch. ALL CASH was bumped in the stretch and empty late. MY HARLEQUIN MAN was bumped at the start while no threat. IMAWARRIOR pressed the pace early, angled off the rail into the turn and bumped a rival in the stretch then folded up.
