Footnotes

SABOULI settled in hand, commended a long drive circling five wide, poked her head in front near the three-sixteenths pole, fought on through the final furlong and held narrowly despite brushing with FAIRNESS in the drive late. FAIRNESS attended the pace along the inside, worked her away out between horses leaving the second turn, drew even between rivals inside the furlong marker, brushed with SLAMMIN ROSE and SABOULI in the drive and wasn't quite good enough. SLAMMIN ROSE settled saving ground, angled out leaving the second turn to make a bold bid, came to level terms with a sixteenth to run, was brushed and floated out a bit and was kept at bay. HILLARY D was allowed to settle, took closer order between horses, came five wide but went evenly through the drive. GREEK BIRD tracked the pace three wide, joined the leader with five-sixteenths to run, disputed the issue to the final furlong and faded. WICKAPECKO was allowed to settle, was shuffled back between rivals on the backstretch, angled out and moved up five wide, but came up empty entering the stretch and failed to seriously threaten. CHOCOLAT CITY opened clear to set the pace, was collared midway through the second turn, stayed on to the final furlong and faded. RICH CHOCOLATE was forwardly placed four wide through the second turn and retreated. THMORUPLATHLESUPAY contended between horses to the second turn and dropped out. GREAT STAR was outrun. The jockey of FAIRNESS lodged an objection against SABOULI for alleged interference through the drive, but following the Stewards review there was no change to the order of finish.
