GLAMOUR GALORE was hustled for position four wide, drew even entering the stretch, forged command and held stubbornly through the drive. TOUCH OF REVENGE was allowed to settle, circled five wide into the stretch, finished well and was gaining with every stride. JUST REALITY settled off of the inside, advanced between horses through the turn, split rivals and loomed a danger four wide but lacked the needed late kick. VIRGINIA ANN dueled two wide, edged clear briefly in the upper stretch, but weakened between rivals and faded. KITTY'S CHARGE broke slow, was unhurried into stride, came five wide and improved position through the lane. TRUPEG was allowed to settle, moved up four wide to offer a mild bid but failed to sustain the drive. DANCE TO ME settled saving ground, got through entering the stretch but lacked a response when called upon. RIBBON TAFFY dueled for the lead along the inside to the stretch and faded. KNOW IN ADVANCE was never a factor. GRAND CHALLENGE saved ground to no avail. JERDAN HILL contended four wide for a half and dropped out.
