JUDICIAL POWER prompted the pace along the inside, took over leaving the turn, shook clear and maintained a safe advantage. CAPTAIN DAVRICK set the pressured pace three wide, was headed leaving the turn, prove unable to match strides with the winner but stayed on well to earn the place. ESPLENDIDO was allowed to settle, came four wide, angled in inside the three-sixteenths pole and was just up to garner the show. PLAY BULL hopped and broke outwardly, moved into contention in hand while four wide, was within striking distance entering the stretch but weakened during the drive and faded. MISTER LUCKY CAT chased three wide, but faltered between horses leaving the bend and retreated. VPERIYOD SERIYOGA was through early.
