APPEALING CAT shadowed the pace three wide, joined the leader nearing the furlong marker, took over and gamely edged clear. SEA ISLAND tracked the pace three wide, tipped out four wide entering the stretch to make a bold bid, but toiled through the drive and was all out to just hold the place. TREASURED UP was allowed to settle, angled out five wide entering the stretch and was making up ground. NEW WAVE tugged to the fore and angled in to set the pace, was collared nearing the furlong marker and gave way readily once headed. STAR PASSAGE contended off of the inside, shifted out three wide entering the stretch but lacked a response when called upon. PREFERENTIAL (GB) was close up along the inside, got through entering the stretch but came up empty in the drive. ANGEL TERRACE saved ground to little avail. EAGLE HALL was unhurried three wide and failed to respond. TRAC N JAM was outrun.
