### Footnotes

COALPORT settled in hand four wide, loomed large entering the stretch and gamely edged clear. FILM SHOT tracked the pace three wide, drew even after a half, kept on well through a prolonged drive but was unable to match the winner. SOUTHERN PARKWAY was allowed to settle, ranged up five wide through the second turn, continued on willingly but was unable to bridge the gap. UNREMITTING settled under a snug hold between horses, moved into striking distance on the second turn, came three wide but lacked the needed late punch. HEIKO opened clear and angled in to set the pace, was collared after a half, disputed the pace to the final furlong and gave way. CLASS PRESIDENT was unhurried into stride, angled out to make a belated gain but failed to threaten. OLD TIME HOCKEY contended between horses, angled in on the second turn, got through entering the stretch but came up empty in the drive. AL MUSADDAD was unhurried into stride and failed to threaten. FANTASTIC SONG made a middle move four wide but failed to sustain the drive. TIGERDUDE saved ground to no avail.
