## Footnotes

ENVISIONING settled between rivals, advanced four wide through the turn, quickened in the final furlong, reeled in TIGER BUD and was inching away late. The latter pulled to contention off of the inside, took over after a half, opened clear leaving the turn, but faltered during the drive and was unable to resist the winner. JUSTIFIER settled saving ground, closed the gap through the turn, angled out and split rivals inside the three-sixteenths pole and was making up ground. GO GETEM was allowed to settle, circled five wide and improved position. SARATOGA VICAR broke a step slow, was unhurried into stride, came five wide and finished with a belated gain. ARTIE LIAM contended off of the inside to the stretch and faded. LUCKY JAZZ opened clear to set the pace, was headed after a half and gave way readily entering the lane. MISTER MONSIEUR showed little. SPARKLING SPRINGS was forwardly placed for a half and dropped out.
