STAKES Maker's Mark Mile S. Grade 1 - Thoroughbred

FOR FOUR YEAR OLDS AND UPWARD. By subscription of \$200 each, which should accompany the nomination or by Supplementary Nomination of \$15,000 at time of entry (includes entry and starting fees). \$1,500 to enter and an additional \$1,500 to start, with \$300,000 guaranteed, of which \$180,000 to the owner of the winner, \$60,000 to second, \$30,000 to third, \$15,000 to fourth, \$9,000 to fifth and \$6,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of \$180,000 at a mile or over on the turf since November 4, allowed 2 lbs.; a Grade I stakes at a mile or over on the turf since October 8, 4 lbs.; a graded stakes at a mile or over in 2010-2011, 6 lbs. Starters to be named through the entry box by usual time of closing. A gold julep cup will be presented to the owner of the winner. A silver julep cup will be presented to the winning trainer and jockey. Closed Wednesday, April 6, 2011 with 17 nominations. In the event that this race is taken off the turf it will be contested at Eight and One Half Furlongs on the main track.

GET STORMY opened clear and angled in to dictate terms, turned back the bid of WORKIN FOR HOPS leaving the second turn, kicked clear and maintained a safe advantage. WORKIN FOR HOPS tracked the pace three wide, moved up to engage GET STORMY nearing the quarter pole, was unable to match strides with that one but stayed on well to earn the place. SOCIETY'S CHAIRMAN was unhurried into stride, took closer order through the second turn, wheeled out seven wide but was left with too much to do. COURT VISION settled saving ground, got through entering the stretch, loomed a danger but lacked the needed late response. BIM BAM broke a step slow, settled between horses, came three wide and finished with a mild gain. FURTHEST LAND was allowed to settle, came six wide but lacked a response when called upon. ZIFZAF was forwardly placed off of the inside to the stretch and retreated. TURALLURE bobbled at the start, chased the pace four wide for six furlongs and dropped out.
