**Footnotes**

NIGHTMARE broke in front, settled in behind front-running SHINY DANCER, raced four wide into the stretch, gained command and was kept to her task. TACTICAL CANDY, outrun three wide to the stretch, came out brushing with COME ON CATHY ANN in the upper stretch putting that one in a bit tight, lugged in about the sixteenth pole tightening it up on TAK WILD, then earned the place. COME ON CATHY ANN, reluctant to load into the gate, bobbled soon after the break, was outprinted to the lane, lacked room briefly at the three-sixteenths pole, worked her way out seven wide in the late going and finished well. TAK WILD raced near the inside, was never far back, eased out three wide in the upper stretch, was bothered by TACTICAL CANDY and steadied at the sixteenth pole, then lacked a final account. SHINY DANCER sprinted clear on the backstretch, raced in the three path, made the pace to the lane and faltered. ELECTRICAL CARLITA tracked the leaders four wide into the final furlong and flattened out. SLEW PROUD raced five or six wide much of the way and was empty in the drive. SWEET TIME, between horses four or five wide to the stretch, weakened thereafter. FOLLOWING A STEWARDS' INQUIRY, TACTICAL CANDY WAS DISQUALIFIED FROM SECOND AND PLACED FOURTH.
