Footnotes

SELF MADE MAN set the pace near the inside, repulsed a bid by CATMAN RUNNING on the backstretch, set the remainder of the pace and drew off under steady handling. DOMINICAN forwardly placed off the inside, angled out for the drive and finished willingly to be up for the place. BIRDBIRDISTHEWORD reserved early, advanced along the inside on the second turn, checked near the furlong marker when attempting to get through along the inside, angled out and made a late bid. I'M WAITING FOR U outrun early, made a good three wide middle move but could not sustain the bid. APPROVAL RATING within striking distance, moved closest to the winner on the second turn while in the four path but gave way in the stretch. EXTREME SUPREME never far back four wide, gave way in the final three furlongs. SPIDER POWER (IRE) outrun to the stretch, could not menace. CATMAN RUNNING closest to the pace off the inside, challenged before a half, tracked the winner to the stretch and faded. SAY IT SON had speed for a half. BADGE OF TRUTH was outrun.
