Footnotes

GATHERING CLOUD behind the leaders three wide, reeled in the leaders after six furlongs, took over with a furlong to go, responded when headed near the sixteenth marker then proved narrowly best in a game effort. UNDER CONTROL (BRZ) squeezed at the start, was outrun for a half, advanced off the inside on the second turn, bumped with TWINSPIRED and VERSAILLES ROAD in upper stretch, challenged inside the final furlong, gained a short lead late but missed. TWINSPIRED drifted out a bit at the start, recovered to race within striking distance three wide, was bumped in upper stretch when rallying, challenged near the sixteenth marker but missed. VERSAILLES ROAD reserved inside, angled out in upper stretch for a clear path, challenged inside the leaders near the sixteenth marker then weakened late. COGNASHENE squeezed at the start, was reserved three wide, moved in a path on the second turn, maintained good position into the stretch but lodged only a mild late bid. BREAK UP THE GAME within reach off the inside, moved out a path on the second turn but lodged only a mild late bid. MANDURAH broke in the air, forced the early pace in the three path, challenged before a half, held on well for six furlongs and tired in the drive. WALKER'S LANDING was outrun. JOES BLAZING AARON set the pace off the inside, moved near the rail on the second turn, held on well to the stretch and faded.
