### Footnotes

MYSTICAL STAR forwardly placed three wide, moved closer on the second turn, dropped back a bit into the stretch then finished well late to be up in time. SKATING closest to the pace off the inside, challenged on the second turn, drew clear into the stretch but missed. JONES ZING within striking distance four wide, was pocketed on the second turn then lacked a late bid. LITIGATING close up along the inside, angled out for the drive but tired. KITTEN'S DANCER in hand for a half, angled out for the drive but could not threaten. CRYPTOCANDIAC set the pace along the inside, held on well to the stretch and tired. JOY IN MUDVILLE within reach of the lead early off the inside, faded.
