**Footnotes**

POINT OF ENTRY settled saving ground, took closer order on the backstretch, worked his way out off of the inside through the final turn, came four wide into the stretch, kicked clear and maintained a safe advantage. TAHOE LAKE (BRZ) settled in hand off of the inside, came three wide into the stretch, angled in splitting rivals inside the three-sixteenths pole, kept on well but was unable to reach the winner. SIMMARD tracked the pace three wide, drew even before going a mile, poked his head in front with a quarter to run, was collared between horses entering the stretch, drifted about through the drive brushing MUSKETIER (GER) near the sixteenth pole, but had enough left to preserve the show. MUSKETIER (GER) attended the pace three wide, was floated out further entering the stretch, was brushed and steadied near the sixteenth pole and went evenly late. NEWSDAD opened clear to set the pace, was collared before going a mile, disputed the issue through the final turn, was headed with a quarter to run and gave way readily. WILKINSON saved ground to little avail. SUNTRACER was unhurried into stride and never a factor. CENTER DIVIDER stumbled at the start and unseated his jockey.
