BALANCE THE BOOKS hopped a bit in the air at the start, was outrun to the stretch while unhurried, angled to the outside once in the stretch, was carried out with a furlong to go. REALLY SHARP closet to the pace off the inside, challenged on the second turn, gained a short lead once in the stretch, swerved out with a furlong to go bothering several rivals then held on gamely to miss. BROWN ALMIGHTY outrun early off the rail, moved up in the three path on the second turn, angled out a bit for the drive, steadied when rallied out in mid stretch then held on gamely. SONOFASAMURAI within striking distance, moved up four wide on the second turn, steadied behind REALLY SHARP when that one swerved out then weakened. SUMMIT COUNTY within reach early, moved up four wide on the second turn, steadied in mid stretch when bothered by STRIKE THE NOTE when that one was roughed and forced out then lacked a late bid. STRIKE THE NOTE forwardly placed three wide, moved up in that path on the second turn, was roughed and forced out in mid stretch then tired. FREDERICKSBURG attempted to drift out early, was unhurried, saved ground on the second turn and was no threat. ROMAN'S AVENUE reserved for a half, raced four wide on the second turn and could not menace. RULER OF LOVE close up along the inside, steadied in traffic in mid stretch

and tired. SLAMARAMA within reach four wide, gave way in the drive. ARMY HERO was outrun. ROAD AGENT set the pace along the inside and faded in the drive. FOLLOWING A FOUL CLAIM BY THE RIDER OF SONOFASAMURAI AND A STEWARDS INQUIRY, REALLY SHARP WAS DISQUALIFIED AND PLACED SIXTH FOR INTERFERENCE IN THE STRETCH.
