### Footnotes

DOGWOODS BARTO broke a step slow, settled in hand, angled in on the turn, got through entering the stretch, shifted to the outside of MY MAN DAN, reeled in that one and edged clear late. MY MAN DAN made a long drive along the inside, got through and assumed command leaving the turn, continued on willingly but was unable to resist the winner. LORD CHELSIE disputed the pace along the inside, weakened entering the stretch but had enough left to hold the show. JONMIL JOHNNY vied for the lead four wide for a half and faded. GIMMEAWISH pressed the pace between horses, but came up empty leaving the turn and retreated. HUDSON'S CREED was allowed to settle four wide and failed to respond. FIVE VICES dropped far back and was never a factor. CONSOLER showed little.
