### Footnotes

ZERMATT stalked the pace three wide, launched a bold bid leaving the turn, shook clear and maintained a safe advantage. DANCINGINHERDREAMS contended between horses, split rivals and continued on well to clearly prove second best. RIDGESTER was hustled along four wide, loomed a danger entering the stretch but lacked the needed late response. HENNY'S HURRICANE was allowed to settle, angled out five wide and improved position. MEGA DREAM broke a bit slow, was unhurried, came three wide and finished with a belated gain. KENNY LANE was close up early, bid between horses, but came up empty in the final furlong and faded. GOLDEN ALLURE failed to respond. SONG OF A SIREN sent clear to set the pace, was collared before going a half and gave way readily once headed. KEIAI TOKYO saved ground to no avail. LOST MY HALO was forwardly placed along the inside to the stretch and dropped out. SOCIAL VINDICATION showed little.
