Footnotes

NEW BELIEVER was allowed to settle, circled seven wide to make his bid, drifted out further through the drive but was up in the final strides. FLEET BEAT stalked the pace, came six wide into the stretch, finished willingly but was unable to resist the winner. FUTURE PROSPECT stalked the pace, bid four wide between horses, continued on well but wasn't quite good enough. GLACIER BAY settled between horses, angled out seven wide and was making up ground. CHIEF COUNSEL attended the pace along the inside, got through entering the stretch but went evenly through the drive. ATTRACTIVE RIDE contended between horses, came five wide but flattened in the final furlong. TIZ TEE TIME was allowed to settle toward the inside, shifted out entering the stretch but lacked a response when called upon. BERGERAC contended between horses to the final furlong and faded. LONGHUNTER (GB) opened clear to set the pace, was collared nearing the furlong marker and gave way readily once headed. BARTLETTS was through early. DYNAMITE BOB trailed.
