Footnotes

ON THE FRITZ settled near the inside early, edged closer approaching the final quarter, eased out and split foes four wide in the upper stretch, then, while inside of BROWN EYED BEAUTY, wore that one down under strong handling. BROWN EYED BEAUTY, never far back while following the leaders five or six wide, moved to the fore in the upper stretch, opened a clear advantage, then failed to contain the winner's surge. PAIGE'S BOO, within easy striking distance while racing near the inside to the stretch, lacked room about the three-sixteenths pole, split foes three or four wide in the final furlong and finished willingly. CAUY bobbed slightly at the break, raced in a striking position four or five wide, moved out seven wide for the drive but lacked a late response. STEAMING HOME, outrun four wide to the stretch, came out seven or eight wide for the drive and improved position while unable to seriously menace. BEAT YOUR FEET, sluggish to begin and outrun to the lane while three or four wide, circled horses 10 wide and offered a minor gain. ALL THAT GLITTERS, sluggish early, failed to rally. NICOLE'S DREAM forced the pace three abreast into the stretch and tired. CRYSTAL SEA attended the pace from early on while between foes, battled with front-running TANGIER SOUND while outside that one around the turn and tired from the effort. TANGIER SOUND gained a slim lead early, edged near the inside, showed the way until the stretch while dueling and faltered.
