Footnotes

TOQUINHO was hung wide through the first turn, settled in hand and tucked in to save ground, shifted back to the outside leaving the five-sixteenths pole, came four wide into the stretch, wore down GATHER ALL and edged clear through the final yards. GATHER ALL opened clear to set the pace, battled through a long drive but was unable to resist the winner late. AZUL MOON settled in the second flight on the outside, responded when put to pressure nearing the three-eighths pole, made a steady advance circling four wide and finished willingly to earn the show. DORIAN WILL chased the pace two wide to the final furlong and weakened. KENTUCKY STORMIN attended the pace along the inside to the second turn, angled out to be clear, offered a mild bid entering the stretch but failed to sustain the drive. HE'S LONG GONE was forwardly placed between horses, dropped back through the second turn, but came again with a mild rally from between horses through the lane. FINAL WARNING was unhurried into stride along the inside, angled out to make a mild rally but failed to threaten. CANNON'S CALL contended along the inside through the second turn and tired. ARDANWOOD broke slowly, made a belated gain circling five wide but was never a factor. KERWIN'S WAY was fractious in the gate, hustled along in mid pack along the inside but failed to menace. DESERT FOX showed little. DREAMS D'ORO failed to respond.
