Footnotes

WALTZINGINREDJEANS vied for the lead off the inside, took over on the turn and lasted late. BRIKSDAL behind the leaders off the inside, rallied willingly but missed. CAT IN THE BAG within striking distance off the rail, was gaining late. ALLEY SPROUT drifted in at the start, was reserved after being straightened, raced off the inside midway through the turn and made a late gain. I'M READY outrun early, raced five wide with three furlongs to go and made a late gain. GRAND ILLUMINATION within reach three wide, lacked a late bid. NOCTIVAGANT outrun along the inside, found her best stride too late. ONEFASTWILDCAT close up three wide, tired. MY FAST ONE forwardly placed in the four path, faded. VALENCIENNE was no factor three wide. SHE'S STUBBORN was no threat. BAY KOHINOR prompted the pace along the inside and stopped.
