Footnotes

HIGH ON KITTEN was unhurried into stride, responded when roused with five-sixteenths to run, angled out five wide leaving the second turn, engulfed the leader inside the furlong marker and edged clear. PRETTY PLEASER settled in hand, made a sweeping move circling five wide, opened clear entering the stretch but was unable to resist the winner. CYPRESS ISLE was allowed to settle, ranged up four wide through the second turn, made a mild bid but flattened during the drive. SMART AND SUAVE set the pressured pace, was headed leaving the second turn and gave way. GOLDEN MEADOW was allowed to settle, came five wide and finished with a belated gain. DEVIL'S CHANCE tucked in to save ground, closed the gap on the second turn, but faltered entering the stretch. CHAMAME was allowed to settle four wide and failed to respond. VERTICAL LIFT contended between horses for six furlongs and retreated. SETAS SASSY SHOES chased three wide, was collared between horses nearing the three-eighths pole and stopped. SHESA LOUIE broke slow, dropped far back and trailed throughout.
