RESCUE SQUAD settled under a snug hold, took closer order between horses through the second turn, split rivals a furlong out and gamely edged clear. ZIMMER was away alertly, angled in to set the pace, opened clear on the second turn, widened into the stretch, continued on well through a long drive but was unable to resist the winner. SCOTUS was allowed to settle, circled five wide and was making up ground. ACHAEMENES broke in the air, settled between horses, worked his way out through traffic entering the stretch and kept on willingly. TWINSPIRED was reserved toward the inside, angled out on the second turn, came six wide and improved position. FIRE WITH FIRE stalked the pace, moved up three wide to make his bid, but faltered between horses and faded. WESTSHORE contended between horses, was floated out leaving the second turn and came up empty in the drive. MAVERICKING was allowed to settle, moved up between horses on the second turn, was jostled between horses near the three-sixteenths pole when PALATINE HILL came in, steadied and showed little thereafter. STRONG APPEAL was unhurried, finished with a belated gain five wide. CONSERVATIVE passed only the tiring ones. PALATINE HILL prompted the pace three wide, came up empty between horses leaving the second turn, drifted in under right handed urging, bumped MAVERICKING near the three-sixteenths pole and dropped out. SPICER attended the pace along the inside, got through entering the stretch, was bumped and steadied near the three-sixteenths pole when MAVERICKING was forced in and stopped.
