KEENELAND COURSE. FOR THREE YEARS OLDS AND UPWARD. By subscription of \$75 each, which should accompany the nomination; \$375 to enter and an additional \$375 to start, with \$75,000 added, of which 62% of all monies to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: Three year olds, 122 lbs.; Older, 124 lbs. Non-winners of a sweepstakes on the turf in 2004 allowed 2 lbs; \$30,000 twice since April 4, 4 lbs.; \$30,000 in 2004, 6 lbs. The maximum number of starters for the Woodford County will be limited to ten. In the event that more than ten horses pass the entry box, the ten starters will be determined at that time with preference by condition eligibility. Same owner entry cannot start to the exclusion of a single entry. Starters to be named through the entry box by the usual time of closing. A silver julep cup will be presented to the owner of the winner. Closed Wednesday, October 13, 2004 with 19 nominations.

Footnotes

BATTLE WON, bumped at the start from both sides, recovered to track the leaders four or five wide, inched to the front in the final sixteenth, then was hard ridden to hold sway. SGT. BERT, outrun to the stretch four wide, came out seven wide for the drive, was going well at the end and appeared to flinch from the rider of the winner's whip on or a step past the wire. CHOSEN CHIEF went up early to vie for the lead four wide, battled with TAKE ACHANCE ON ME to the lane, took over, then grudgingly weakened late. ABDERIAN (IRE), outrun to the stretch, advanced five or six wide and offered a mild gain. WILDCAT SHOES, outsprinted early, raced near the inside, worked his way out five wide in the final furlong and improved position while unable to menace. JUSTICE FOR AUSTON broke in front, raced in a striking position three or four wide to the stretch and weakened. MIGHTY BEAU broke to the inside, raced in behind the dueling leaders, moved with the winner while just inside that one leaving the turn and faltered in the drive. DRAW FIRE leaned in at the start bumping BATTLE WON and wasn't a factor. MARLEY'S REVENGE came out at the start on the winner, raced in contention five wide to the stretch and tired. TAKE ACHANCE ON ME gained a slight edge inside early, battled with CHOSEN CHIEF to the stretch and tired.
