Footnotes

PARSE settled saving ground, wheeled to the outside leaving the turn, finished with a rush and reeled in MY SHEPERD GIRLS in the final yards. MY SHEPHERD GIRLS dueled along the inside, shook clear entering the stretch, kept on well but was turned away late. MAUDE S was close up between horses, waited in traffic leaving the turn, got through three deep but wasn't quite good enough. CAT IN THE BAG was allowed to settle, split horses and came three wide to improve position through the stretch. SOUTHERN MINX dueled two wide to the stretch and weakened. SYN NO MORE settled in the second flight, got through along the inside and finished with a mild rally. DAYLASOUL attended the pace three wide in hand, but faltered between horses after five furlongs and faded. FIRST WHIPPOORWILL was allowed to settle, closed the gap three wide through the turn, came four wide but failed to sustain the drive. FIRST PRIZE failed to respond. MUSIC OF ARABIA was allowed to settle four wide and showed little. BROADWAY TUNE hopped at the start to get away slow and never recovered. COME SLEW ME was forwardly placed along the inside but stopped leaving the turn and dropped out.
