JAMALUDIN settled in hand, advanced five wide down the backstretch, forged command entering the stretch, opened clear leaving the three-sixteenths pole, had his rider lose the whip nearing the furlong marker but continued on willingly to maintain a safe advantage. ON FIRE was unhurried into stride, responded when put to pressure with three furlongs to run, circled five wide and closed willingly but was unable to reach the winner. AVENSTOKE attended the pace along the inside, shifted to the outside entering the stretch but went evenly through the drive. BORDER CAT stalked the dueling leaders two wide, came three wide to engage the leader leaving the second turn, but weakened during the drive and gave way. SR. HENRY was allowed to settle into stride, ranged up four wide to make a mild bid, but had his jockey lose the whip near the quarter pole and flattened out. TORINI was allowed to settle into stride, came five wide to make a mild rally but failed to seriously threaten. DIAMOND TYCOON dueled for the lead along the inside to the stretch and tired. BLUE LION was forwardly placed between horses for six furlongs and gave way. PONT DES SOUPIRS showed little. FLYING ZOMBO saved ground to little avail. SAN BELLARMINO dueled two wide for a half and stopped.
