RAHYSTRADA reserved four wide, advanced five wide on the second turn, challenged once in the stretch and drew clear under steady urging. ATTEMPTED HUMOR within striking distance, moved up three wide on the second turn, angled out for the drive and finished willingly to be up for the place. PICK SIX outrun off the inside, found his best stride late. ATONED five wide on the first turn when forwardly placed, dropped back after a half then passed tiring rivals. CRESTED (GB) close up four wide, tired in the drive. WISE RIVER alternated for the lead near the rail, held on well to the final furlong and tired. ANTRIM COUNTY with the pace in the three path, faded. STARSPANGLED GATOR steadied around the first turn when too eager, raced in hand for a half and could not threaten.
