MRS. GUILTY, outrun for a half, was angled out to advance three wide on the second turn, caught the leaders with a furlong to go and proved narrowly best. DARLING ALICE, reserved off the inside, followed the winner after six furlongs and finished willingly to miss. DYNAFINE, closest to the pace, advanced off the inside on the second turn, gained a short lead between calls approaching the furlong marker but weakened in the final furlong. PANTUFLA, outrun for six furlongs, was angled out five wide leaving the second turn and finished willingly. LORDS GUEST three wide on the first turn when in midpack, lacked a solid closing bid. IMAGINATION, unhurried early, was fanned four wide on the second turn and could not threaten. BONITA SPRINGS sprinted to a long lead but gave way badly in the final furlong. ARRIVE ALIVE, reserved inside, was through after six furlongs.
