CAPE SAN BLAS was unhurried into stride and tucked in to save ground, ranged into striking distance through the second turn, angled out and split horses four wide entering the stretch, struck the front nearing the sixteenth marker and gamely held sway. WHIRLING THUNDER was away alertly and dropped to the inside mid way through the first turn, prompted the pace along the rail, edged clear entering the stretch, kept on well through a prolonged drive but was grudgingly gave way late. KING OF SPEED settled in hand, swung seven wide to make a bold bid, loomed large inside the final furlong but was unable to reach. EIGHTEENTHOFMARCH was allowed to settle, advanced from between horses, angled out six wide to make his bid from between horses but lacked the needed late response. INTI (URU) broke a step slow, was unhurried into stride, made his rally six wide but found his best stride too late. RICHLAND CREEK tracked the pace three deep, drew even leaving the second turn between horses, but failed to sustain the drive. TEMPLAR'S CUP attended the pace along the inside, got through to make a mild bid but faltered. PASTER'S BAD HABIT made a middle move five wide, loomed a danger entering the stretch but came up empty in the final furlong. U D GHETTO contended between horses three wide for six furlongs and dropped out. T. C. CHAMP opened clear to set the early pace, was collared after a half, disputed the issue to the stretch and stopped.
