GALLOPING DOMINO sprinted clear, set the pace along the inside and prevailed while fully extended. CHERRY WILDCAT close up along the inside, angled out once in the stretch and rallied willingly to just miss. CHA CHING JACKPOT outrun for a half, came five wide into the stretch and closed well on the outside. SAILORS PASTTIME unprepared at the start, quickly gained good position, waited behind rivals late on the turn then lodged a mild bid along the inside. ALPHA NOVA outrun early, raced five wide into turn, maintained position to the stretch and made a late gain. ANAPPLEFORAQUEEN within striking distance four wide, dropped back on the turn and into the stretch then made a late bid. KAN N KLEAR within reach early inside, dropped back on the turn then improved her position late. MAC N MAYO outrun five wide, failed to threaten. ALL COUNTY prominent three wide, tired. EMBELLISHED GOLD pressed the pace off the inside and gave way. IN THE FRAME was no factor.
