Footnotes

HOSTILE REACTION dueled for the lead from the outside into and around the turn, then dug in late and got up in the final strides. RAISING SUZZIE dueled for command from along the inside through the turn and into the stretch, battled gamely late but was outfinished by the winner. BLOOM TIME tracked off the pace down the backstretch, took the turn three wide, then closed well in the late stages. HOUSE OF CRYSTAL settled off the pace, saved ground along the rail, then finished with a mild rally. VICTORIOUSLY failed to show early speed, traveled a bit off the rail into the stretch, then passed tired foes. CONDITIONER off slow, chased the speed from the outside into the turn, raced four wide into the stretch and failed to rally. CASUAL ENCOUNTER allowed to settle in the early going, went two to three wide around the bend, then failed to respond when asked.
