**Footnotes**

FOR CONTRAST broke alertly and quickly established command while crossing over, set uncontested pace while hugging the rail and safely held under confident handling in late stages. FORD ISLAND settled off the pace, chased while bit off the rail then two wide into the stretch and whittled gap on winner in deep stretch. SEAFIRE was void of early foot, shifted out and came three wide into the stretch, angled out further in upper stretch and found his best stride late. THUNDER ONE was closest pursuer to pacesetter to the turn, came out some leaving the turn and was overtaken for third. NATIONWIDE FAMILY saved ground chasing the pace and lacked needed late response. BIG SWISS was washy in the post parade, chased outside foe then along the rail and was outrun.
