WYLIE N WYATT well placed behind the early speed duel, took the turn two wide, angled out in the upper stretch, then closed fast from the outside to overhaul foes for the victory. GEORGIA'S FRIEND duelled from the inside into and around the bend, battled down the lane, then was overtaken by the winner but finished willingly to hold the place. LINCECUM duelled for the lead from the outside into and around the turn, was outfinished by the winner but went willingly late gain the place. DIRTY DEED chased the speed four wide around the bend, then finished evenly late. SHERMAN BARTLEBORT settled off the pace early on, saved ground along the rail into the lane and raced evenly through the stretch. A BIG SWEET TOOTH attended the pace three deep off the fence, then weakened in the stretch. WARREN'S CONCEPT showed no early speed, traveled a bit off the rail, lacked room and steadied in the upper stretch, then improved after gaining a clear path. BELLA MARINO raced near the back of the field, saved ground along the rail and proved no menace. KID ATLANTIC allowed to settle in the early stages, angled in to race near the inside, then failed to respond when asked. WYLIE N WYATT WAS DISQUALIFIED FROM FIRST TO UNPLACED FOR A MEDICATION VIOLATION.
