BEST GIRL EVER pressed the pace from the outside, moved up to duel around the turn, cleared foe in the stretch, then weakened a bit late but was able to last. SHAMROCK BAY settled off the pace, raced three wide around the bend, closed fast from the outside but was too late. LADY DELANEY set the early pace, dueled while along the inside around the turn, then weakened in the stretch. PROPER DATE trailed the field early, saved ground into the lane, showed a mild rally and improved position. BROUGHT TO JUSTICE raced near the back of the field, went two wide into the stretch and proved no menace. JEANNE MARINI stalked the leaders along the rail into the turn, raced in the two path around the bend and weakened in the drive.
