Footnotes

BEV'S EX was hustled to front while angling over, resisted when challenged into and around the turn, regained command in upper stretch then edged away under urging. FOR CONTRAST forced the early issue then bid alongside pacesetter leaving backstretch, battled outside that rival around the turn, fanned three wide into lane then lost contact and held for second. FORD ISLAND settled outside rival, chased three wide into the bend, angled inward through the drive and finished strongly inside. GET OFF THE SUGAR was bumped and forced inward leaving the gate, stalked from the inside, remained along the rail and finished evenly. SEAFIRE bumped at the start while also coming inward, reserved early, chased on two wide path into the stretch and never menaced. NATIONWIDE FAMILY reserved from off the rail, chased three wide, drifted out further around the turn and was outrun.
