LAKE OSCEOLA dueled for command from the inside into the turn, cleared foes around the bend, then powered away in the stretch. CEE CALLY DANCE tracked off the pace, saved ground along the rail, then went willingly to prove second best. STORM FLEUR traveled near the back of the field early, raced off the rail around the turn, then showed a mild rally to gain third. AURELIA D stumbled leaving the gate, unhurried after and raced along the inside, came out into the stretch and showed a mild response to urging. DANCE LITTLE ANGEL failed to show early speed, traveled off the rail into the stretch and passed tired foes. ANNIE'S JOURNEY settled off the pace, saved ground along the rail and never rallied. ROYAL CHAVELA allowed to settle on the backstretch, raced in the two path into the lane and prove no menace. WINE N MAXINE dueled from the outside with the winner into the turn, lost ground around the bend, lugged out into the stretch and gave way. STUDIO CITY attended the pace from three deep early, lost contact with the leader around the bend and faded down the lane.
