**Footnotes**

ROBYN DANCERS SON forced the early pace from the inside, was eased back then taken off the rail, reeled in leader through the lane and safely held. LORD MACHO bumped at the break, lugged inward nearing the turn, saved ground into the lane, came back out some inside sixteenth marker and finished strongly. ALLNXS emerged from the pack to gain early command, crossed over and padded lead, continued inside but had little resistance for winner and lost second late. MEXICO EXCESS bumped at the start, prominent early, gradually angled over, later found the fence and finished very willingly. EL JACAL close up while outside rival, continued on three wide path around the turn and lacked needed late response. CARRY JIG in tight and squeezed back in the early going, chased on four wide path to the stretch and never menaced. STERLING IMAGE bumped early from between foes, was forced inward then checked off heels approaching the turn and never recovered. JOE AUGUST bumped repeatedly with inside rival early, then forced to steady sharply off heels nearing the turn and never recovered. PIZZA PETE bumped repeatedly with outside rival early, dropped back, was taken off the rail and lacked any response. The rider of PIZZA PETE lodged a claim of foul again JOE AUGUST, and there was also a stewards inquiry into the incident on the backstretch, but there was no change in the order of finish.
