CAJUN GENT sped clear of the field and set the pace, traveled in the two path and received challenge from the inside on the bend, dueled through the lane and dug in gamely to outkick rival. FOREST PRINCE chased the speed down the backstretch, angled in entering the turn, bid from along the inside and gained the lead leaving the bend, dueled with the winner in the stretch but was outfinished. CAPTAIN SHAWN D tracked the pacesetter early on, raced a bit off the rail around the bend, then finished evenly. ARRESTING OFFICER traveled at the back of the field, raced along the inside through the turn and proved no menace. SMOKIN MOTION was off awkwardly to begin, took the turn two wide while still near the back and was never a factor.
