HARRY POTTER BRYAN outfinished. QUEENLY WALK steadied sharply 1/8. LOSE CONTROL off slow, no threat. SCATTER SUNSHINE bumped off stride 1/8. Following a stewards' inquiry, FURIOUS ADDICTION was disqualified and placed tenth for ducking in passing eighth marker and bothering inside horses.
