TAC OF THE TOWN drifted in, veered in late. OUR KINDA MAGIC drifted out, gamely. NO TIME TO FIRE lugged in, shied from rival late. LAST TO CHECK HIM off slow, lost path, gamely. FANNIES DASHER stumbled, drifted out. LADIES ROYAL SIX drifted out, drifted in. PUTTER BILL broke in, awkward step, vanned off. CROWN OF FIRE off slow, veered in start. The rider of NO TIME TO FIRE placed an objection against the winner, TAC OF THE TOWN, for veering in and causing NO TIME TO FIRE TO shift in late in the race. The stewards ruled that even though TAC OF THE TOWN veered in and caused NO TIME TO FIRE to shift in, it did not coast her a chance at a better position.
