**Footnotes**

CATIFORNIA DREAMIN dueled three abreast from the outside early, gained slim advantage on the turn, came in slightly and brushed foe in upper stretch then edged away and safely held. OUT OF SEATTLE settled inside, chased two then three wide into the stretch, responded when roused and rallied strongly in final sixteenth. SIENA GOLD contested the pace from the inside, continued along the rail prominently into the lane but gave some ground late and held third. HOUSE OF CRYSTAL settled off the pace then came off the fence, advanced some in upper stretch, was bumped and jostled from between foes passing sixteenth marker and improved placing late. ALL JOY forwardly placed early from the inside, stalked three wide into the lane, bumped with inside rival in the drive and failed to menace. SOUTH WITH A ROAR dueled from between foes to the turn then inside winner, brushed with that rival in upper stretch, later bumped with outside foe and weakened. SOTA DE OROS lagged back early while angling over, saved ground into the stretch but was no factor. WORLD CELEBRITY was fractious and unseated rider in the gate, still broke alertly, settled off the pace from the outside, remained three wide, then did not return to be unsaddled and was vanned off. The rider of SOUTH WITH A ROAR claimed foul against the winner for interference in the stretch but the stewards disallowed the foul claiming the incident had no bearing on the original order of finish.
