**Footnotes**

HOUSE OF CRYSTAL was slow into stride, lagged back early, shifted out and caught four then five wide into the stretch, continued rally from far outside and nailed rival in final strides. RHONDA LEE chased the pace from the inside, came off the fence, awaited room approaching the stretch, found clear path in upper stretch, surged to the front, edged away but could not stave off winner. MING ROSE chased from the outside early, continued three then four wide into the stretch and rallied gamely from well off the rail to gain third. POMME FRITE settled well off the rail, caught four wide into the turn, came in slightly and improved from between foes in the drive. FREE SUSITA settled off the leaders while angling in, was three wide into the turn, came in bit, checked off rival entering the lane, recovered and rallied strongly in final sixteenth. SUNSET SONATA sprinted well clear early, dictated the pace while slightly off the fence into the lane, lugged out while weakening and gave way late. MOM'SMEDICINEMONEY reserved while outside rival and saving ground, came out exiting the bend and lacked needed response. TRUELY COMICAL stalked from the inside, hugged the rail into and through the stretch and was no factor. FLIP 'N' SIS stalked while outside rival and later between foes, loomed in upper stretch but weakened in the drive.
