Footnotes

FORD ISLAND was off bit awkwardly then came in slightly, dueled from between rivals, gained advantage on the turn, stretched then margin while securing the rail and safely held under urging. SELF DEFENSE stalked from along the rail, briefly came off the fence then regained rail leaving the turn then whittled gap on winner late. SEAFIRE reserved from well off the rail, chased three wide around the turn, remained outside in the lane and finished with interest. PREPPY PILOT broke off balance, in tight and steadied leaving the chute, shifted out and forced the pace three deep, continued off the rail then dropped back in upper stretch and weakened. BREEZY JOHNNY contested the pace from along the rail, dropped back while trying to lug out around the turn, then gave way readily in the stretch, did not return to be unsaddled and was vanned off. A claim of foul by the rider of PREPPY PILOT against FORD ISLAND for interference shortly after the start was no allowed.
