NORCO PAL dueled outside rival early, gained slim advantage on the turn, edged away into the lane, dug in when challenged in deep stretch and gamely held. CHIEF'S LAKE tracked leaders early from the inside, angled out into the turn, came three wide into the stretch, drifted in bit, loomed outside foe late but was turned back. SPEEDY SWISS contested the pace from the inside into the bend, lost lead around the turn, remained along the rail but could not match top pair late. SOMETHING SONIC was off bit awkward, shifted in gradually and found the rail, moved up bit around the turn, came back out and failed to sustain rally. SEAFIRE reserved from the inside, saved ground throughout but failed to menace. MY MASTER (ARG) settled off the rail then outside runner-up, chased four wide around the turn and never reached contention. THUNDERFRMDOWNUNDR was washy going to the gate, broke out, lagged back early, later angled in some but was outrun.
